ARE CELL PHONES THE FUTURE FOR FLIGHT CHECK-IN?

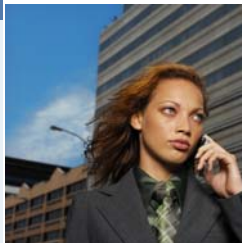
In the next few years, printed boarding passes may not be required at the airport. A bar code, scanned from a traveler's cell phone, could be the way of the future.

Last month, the International Air Transport Association (IATA) announced that major airlines had agreed upon a global standard for such a bar code, which could be text-messaged to a traveler's cell phone or PDA. An alternate option would be that the passenger could receive the bar code by email and print it.

Establishing the global standard for the bar codes is the first step, followed by the creation of standardized processes and guidelines for global implementation.

The deadline for implementing 100 percent bar-coded boarding passes is 2010. If successfully deployed, this option could help the airline industry greatly reduce the need for paper boarding passes and save more than \$500 million USD annually.

SPARE LITHIUM BATTERIES BANNED FROM CHECKED BAGS

Earlier this year, the US Department of Transportation imposed a ban on spare lithium batteries (batteries not installed in a device) from checked luggage to reduce the risk of fires. Passengers are still able to check lithium batteries if they are installed in electronic devices, like cameras, laptop computers, and cell phones.

Travelers can transport up to two spare lithium batteries in carryon luggage, if contained in original factory packaging or separate plastic zipper bags. Additional details about the ban can be found at http://safetravel.dot.gov/whats_new_batteries.html.

FEDROOMS® FAQs

Q: FedRooms® Rates are stated to be at or below federal per diem, but when I called the hotel and asked for the government rate it was more than per diem. Why?

A: The FedRooms® Rate and the government rate **are not the same**. In order to receive the guarantees associated with the FedRooms® Rate (at or below per diem, 4pm or later date-of-arrival cancellation policy within the U.S., no cancellation fees), you must ask for it by name.

Q: Many hotels that offer government per diem rates are not listed on your website. Why?

A: FedRooms® has come up with an equation for the appropriate number of hotels in each city based on government SmartCard spend data. This equation factors adequate coverage for travelers, as well as benefits of participation for hotels (increased government business).

However, some hotels may not have submitted a request to be in the program, or we may not know about a city that your agency travels to frequently. That is why we included a "[nominate a hotel](#)" link on [FedRooms.com](#), where travelers can recommend a hotel or a city for inclusion.
