<b>Getting Started</b>	<ul style="list-style-type: none"> <li>✓ Estimate what your annual health/dependent care out-of-pocket expenses run each year.</li> </ul>	<ul style="list-style-type: none"> <li>✓ If you have predictable dental or vision expenses for you or your family, first see whether your health insurance plan covers them.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Check to see if your current health plan is leaving the Program next year or if its service area is changing.</li> <li>✓ Check premium you will pay next year for your current health plan.</li> </ul>

<b>Getting Started (Cont.)</b>	<ul style="list-style-type: none"> <li>✓ Check if your health, dental, or vision insurance coverage will be different next year.</li> <li>✓ Review the FSAFEDS Eligible Expense Listing at <a href="http://www.FSAFEDS.com">www.FSAFEDS.com</a> for an extensive list of eligible expenses.</li> <li>✓ Use the FSAFEDS calculator at <a href="http://www.FSAFEDS.com">www.FSAFEDS.com</a> to help determine how much to set aside.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Check the premium you will pay next year.</li> <li>✓ Review your current plan's benefit brochure to see what changes were made for covered services and supplies. See if your out-of-pocket costs are changing.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Determine what enrollment type best meets your needs. Note the new Self Plus One enrollment type that will cover you and one eligible family member.</li> <li>✓ Review your current health plan's 2017 brochure to see what changes were made for covered services and supplies. See if your out-of-pocket costs are changing.</li> <li>✓ Determine what is the best type of health plan for you – <a href="#">Fee-for-Service Plan, Health Maintenance Organization Plan, High Deductible Health Plan, or Consumer Driven Health Plan.</a></li> </ul>
<b>Reviewing Your Options</b>	<ul style="list-style-type: none"> <li>✓ An FSAFEDS account will reimburse eligible health care expenses for you, your spouse, and your eligible dependents that are not covered or reimbursed by FEHB, FEDVIP, or other insurance, including reimbursing FEHB and FEDVIP copayments and deductibles (but not premiums).</li> </ul>	<ul style="list-style-type: none"> <li>✓ You can quickly compare dental and vision plans by going to <a href="http://www.opm.gov/FEDVIPcompare">www.opm.gov/FEDVIPcompare</a> and using our "Compare Plans" tool.</li> <li>✓ You may also use a tool provided by Consumer's Checkbook. <a href="http://www.checkbook.org/newhig2/hig.cfm">http://www.checkbook.org/newhig2/hig.cfm</a></li> </ul>	<ul style="list-style-type: none"> <li>✓ You can quickly compare health plans by going to <a href="http://www.opm.gov/fehcompare">www.opm.gov/fehcompare</a> and using our "Compare Health Plans" tool.</li> <li>✓ You may also use a tool provided by Consumer's Checkbook. <a href="http://www.checkbook.org/newhig2/hig.cfm">http://www.checkbook.org/newhig2/hig.cfm</a></li> </ul>

<b>Reviewing Your Options (Cont.)</b>	<ul style="list-style-type: none"> <li>✓ Dental and vision care are eligible expenses whether combined with FEDVIP coverage or not.</li> <li>✓ The Dependent Care FSA reimburses eligible dependent care (non-medical) expenses, covering expenses such as child care, before and after school care, and adult daycare.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Add up the premium and out-of-pocket costs for the plans that interest you. Determine whether this amount is more or less than what you expect to receive in benefits. Know the annual limits on what the plan will pay you.</li> <li>✓ Consider enrolling in an FSAFEDS account to reimburse you for your out-of-pocket dental and vision costs.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Consider enrolling in an FSAFEDS account to reimburse you for your out-of-pocket health costs.</li> </ul>
<b>If You Want to Make a Change</b>	<ul style="list-style-type: none"> <li>✓ You <b>must</b> re-enroll during Open Season – your FSA enrollment does not automatically renew from year to year. Re-enroll at <a href="http://www.FSAFEDS.com">www.FSAFEDS.com</a> or call 1-877-372-3337.</li> </ul>	<ul style="list-style-type: none"> <li>✓ You may enroll or make changes to your enrollment online at <a href="http://www.BENEFEDS.com">www.BENEFEDS.com</a>. You cannot do this through your agency's self-service system or with a registration form. You will need your user ID and password or create a new account. You may also call BENEFEDS at 1-877-888-3337.</li> </ul>	<ul style="list-style-type: none"> <li>✓ Most agencies offer two ways of making changes during Open Season: <ol style="list-style-type: none"> <li>1. Through the agency's online self-service system. <b>You will need your password to log in.</b></li> <li>2. By submitting a Health Benefits Election Form, SF 2809. Make sure you know where to turn in this form.</li> </ol> <p>Check with your agency to see what it requires.</p> </li> </ul>

<b>If You Do Not Want to Make a Change</b>	<ul style="list-style-type: none"> <li>✓ If you do not enroll, then you will not participate for the next plan year.</li> <li>✓ You <b>must</b> re-enroll during the Open Season – your FSA enrollment does not automatically renew from year to year. Re-enroll at <a href="http://www.FSAFEDS.com">www.FSAFEDS.com</a> or call 1-877-372-3337.</li> </ul>	<ul style="list-style-type: none"> <li>✓ If you are satisfied with your dental or vision insurance benefits and the price you will pay next year, you do not have to do anything. Your enrollment will automatically continue.</li> </ul>	<ul style="list-style-type: none"> <li>✓ If you are satisfied with your health insurance benefits and the price you will pay next year, you do not have to do anything. Your enrollment will automatically continue.</li> </ul>
